

1. Background

The Ministry of Micro, Small and Medium Enterprises issued a notification dated 26th June 2020 regarding revision of definition of Micro, Small and Medium Enterprises (MSMEs) and process of registration. Apart from the old criteria of categorization of MSMEs on the basis of investment in Plant and Machinery/Equipment, an additional criterion of turnover has been included. Moreover, the difference between manufacturing and services sector has been removed and now both are at the same level of treatment. This revision is paving the way for strengthening of AtmaNirbhar Bharat Abhiyan and growth of the MSMEs. Particularly, the provision of excluding the exports from counting of turnover is encouraging the MSMEs to export more and more without fearing to forego the benefits of being an MSME.

As a result of change in classification criteria w.e.f. 1st July 2020, an Enterprises is being classified as a Micro, Small or Medium Enterprises on the basis of the following criteria, namely: --

- a) **Micro Enterprises:** where the investment in plant and machinery or equipment does not exceed one crore rupees and turnover does not exceed five crore rupees;
- b) **Small Enterprises:** where the investment in plant and machinery or equipment does not exceed ten crore rupees and turnover does not exceed fifty crore rupees; and
- c) **Medium Enterprises:** where the investment in plant and machinery or equipment does not exceed fifty crore rupees and turnover does not exceed two hundred and fifty crore rupees.



To facilitate the procedure of MSME registration in accordance with the revised MSME definition, Ministry of MSME launched a portal- Udyam Registration Portal (<u>https://udyamregistration.gov.in</u>) on 1st July 2020.

Key features of the portal are as under:-

- It is a unified portal with registration process free of cost, paperless and digital.
- The portal is aimed at reducing transaction time and cost for entrepreneurs and promotes Ease of Doing Business.
- The new MSME registration process is simple, seamless and entrepreneur friendly.
- All the relevant data is being fetched from Income Tax and GST Networks at the backend.
- Udyam Registration is mandatory to avail benefits under most of the schemes of Ministry of MSME and availing credit from financial institutions as per RBI notification no. RBI/2020-2021/26 dated 21st August, 2020. (https://www.rbi.org.in/Scripts/BS_CircularIndexDisplay.aspx?Id=11951)
- Ministry of MSME has also commenced API integration of Udyam Registration portal with GeM so that MSEs can participate in Government procurement easily.

M/o MSME has issued a notification on 5th March, 2021 for certain amendments in the earlier notification dated 26th June, 2020. The amendments made are as follows: -

- 1. The exemption from the requirement of having GSTIN shall be as per the provisions of the Central Goods and Services Tax Act, 2017 (12 of 2017).
- 2. In case of any proprietorship Enterprises not registered under any Act or rules of the Central Government or the State Government, the proprietor may use his or her PAN for registration of the Enterprises in the Udyam Registration portal and for all other types of Enterprises PAN shall be mandatory.

Highlights of the Udyam Registration process are as under:

- Aadhaar/PAN is required for registration;
- After completion of the process of registration, an Udyam Registration Certificate will be issued;
- This certificate will have a dynamic QR Code from which the web page on Udyam Registration Portal and details about the Enterprises can be accessed;
- There will be no need for renewal of Registration;
- PAN & GST linked details on investment and turnover of Enterprises will be taken automatically from the respective Government databases;

• No Enterprises is supposed to file more than one Udyam Registration. However, any number of activities including manufacturing or services, or both, may be specified or added in one Registration.

• 9 Lakh MSMEs onboarded on Government e-Marketplace (GEM) portal (<u>https://gem.gov.in/</u>) using Udyam Registration. It is a two-step process to tap government marketplace for product and services.

2. Distribution of Micro, Small and Medium Enterprises

26,42,250 MSMEs were registered on Udyam Registration portal comprising of 24,48,994 Micro (93%); 1,69,423 Small (6%) and 23,833 Medium (1%) Enterprises.




Figure 1 Distribution of Micro, Small and Medium Enterprises

3. Distribution of Micro, Small and Medium Enterprises in Top 10 States

Maharashtra has the highest number of Enterprises with 23% of registered Enterprises followed by Tamil Nadu (11%), Gujarat (9%), Rajasthan (8%), and Uttar Pradesh (8%).




Figure 2 Distribution of Micro, Small and Medium Enterprises: Top 10 States/U.T.s

The graph below shows top 10 states/UTs for Micro Enterprises. It can be observed that Maharashtra has the highest number of Micro Enterprises with 24% of all Micro Enterprises. The rest of the states are Tamil Nadu (11%), Gujarat (9%), Rajasthan (8%), and Uttar Pradesh (8%).




Figure 3: Distribution of Micro Enterprises: Top 10 States/U.T.s




Figure 4: Distribution of Small Enterprises: Top 10 States/U.T.s





Figure 5: Distribution of Medium Enterprises: Top 10 States/U.T.s



Figure 6 Distribution of Micro, Small and Medium Enterprises: Northern Region


Rajasthan, Uttar Pradesh, Haryana and Delhi dominate the Northern region





Figure 9: Distribution of Micro, Small and Medium Enterprises: Western Region



Figure 10: Distribution of Micro, Small and Medium Enterprises: Central Region


The above graph indicates state wise Udyam Registrations of MSMEs in Central Region.

Figure 12 showcases top 10 districts for MSME registrations. As it can be seen among the top 10 districts, four districts are from Maharashtra, two from Tamil Nadu and Gujarat, one each from Karnataka and Rajasthan.




Figure 13: Distribution of Micro Enterprises : Top 10 Districts

In the country, the highest registrations of Micro Enterprises are from Pune district which are 3.6% of the total registrations, followed by Thane (2.9%), Mumbai (Suburban) (2.17%), Jaipur (2.2%), and Bengaluru (Urban) (2.15%).




Figure 14: Distribution of Small Enterprises : Top 10 Districts

The highest number of Small Enterprises registrations is from Mumbai, Bengaluru, Surat, Ahmedabad, Pune, Chennai, Mumbai Suburban, Thane Jaipur and Kolkata with a total of 15.79% of Small Enterprises registered in these 5 districts.





Figure 15: Distribution of Medium Enterprises : Top 10 Districts

The top 10 districts having Medium Enterprises registration, district wise, are indicated in the above graph. It can be observed that the highest number of Medium Enterprises are registered in Mumbai (5.44%), followed by, Bengaluru and Ahmedabad (3.57%) and Kolkata (3.07%) etc.



6. Udyam Registrations in Aspirational Districts

The above graph (figure 16) indicates top 10 Aspirational districts in terms of Udyam registration of Micro, Small and Medium Enterprises. The Aurangabad district has highest number of MSME registrations, followed by Jalgaon, Ranchi and Virudhunagar etc.

7. State wise Employment





Figure 17:Top 10 States/UTs with highest number of Employment and Average Employment per firm

Above graph showcases top 10 States/UTs with highest number of employment and the average employment per Enterprises in these states. It can be seen that even though Maharashtra has highest employment among MSMEs, the average employment per firm is less than 10 (7.11), however in Telangana, the average employment per firm is 17.98, West Bengal (17.85) and Delhi (15.60).





It can be seen from the above graph (figure 18) that Maharashtra has the highest employment in Micro Enterprises with a total of 27,88,715 employees and the average employment per Enterprises is 4.79 whereas Telangana has 11,26,140 employment in Micro Enterprises with an average employment 13.96 persons per Enterprises.




Figure 19: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Small Enterprises

The state wise distribution of employment in Small Enterprises among the top 10 States/UTs is highlighted above with Maharashtra generating the highest employment and the average employment per Enterprises is varying from 24 to 52 persons.




Figure 20: 10 States/UTs with highest number of Employment and Average Employment per firm: Medium Enterprises

The above graph (figure 20) indicates the state wise distribution of employment in Medium Enterprises among the top 10 States/UTs. It can be observed that Maharashtra, Tamil Nadu and Gujarat have the highest employment in Medium Enterprises.

8. Gender wise distribution of Enterprises

The graph below highlights the percentage distribution of MSMEs by nature of ownership. Males owned Enterprises constitute 73.3% of Enterprises followed by female owned Enterprises at 21.1%. The rest are constituted by other and unidentified firms.




Figure 21: Percentage distribution of Enterprises by gender wise ownership of Enterprises

9. Social Category wise distribution of Enterprises




Figure 22: – Percentage distribution of Enterprises by social category wise ownership

Figure 22 shows (below) percentage distribution of Enterprises owned by various social categories. General owned Enterprises constitute 64% of Enterprises. OBCs own 27% of Enterprises, followed by SCs with 6% ownership and STs with 2% ownership.

A total of 38,783 Udyam registrations are owned by entrepreneurs belonging to Divyangjan Category. The graph highlights the distribution of MSMEs among them.




Figure 23: Enterprises owned by people belonging to Divyangjan

11. Type of Enterprises by Organization Type




Figure 24: Distribution of Enterprises by the nature of ownership

Figure 24 showcases the distribution of Enterprises by the nature of ownership. It can be observed that the most preferred form of ownership is Proprietorship which constitutes more than 86% of the organization type. Other preferred modes of ownership include Partnership (8%), Private Limited (6.5%) etc.

Most number of Enterprises registered on the Udyam portal are Service based constituting 16,52,799 (62.5%) registrations as compared to Manufacturing with 9,89,452 (37.5%) registrations.




Figure 25: Type of Enterprises by nature of business





Figure 26: Top 5 NIC distribution of Manufacturing Enterprises




Figure 28 Top 5 NIC distribution of Enterprises: SC ownership




Figure 29: Top 5 NIC distribution of Enterprises: ST ownership




Figure 30: Top 5 NIC distribution of Enterprises: Women ownership


