

1. Background

The Ministry of Micro, Small and Medium Enterprises issued a notification dated 26th June 2020regarding revision of definition of Micro, Small and Medium Enterprises (MSMEs) and process of registration. Apart from the old criteria of categorization of MSMEs on the basis of investment in Plant and Machinery/Equipment, an additional criterion of turnover has been included. Moreover, the difference between manufacturing and services sector has been removed and now both are at the same level of treatment. This revision is paving the way for strengthening of AtmanirbharBharatAbhiyan and growth of the MSMEs. Particularly, the provision of excluding the exports from counting of turnover is encouraging the MSMEs to export more and more without fearing to forego the benefits of being an MSME.

As a result of change in classification criteria w.e.f. 1st July 2020, an Enterprises is being classified as a Micro, Small or Medium Enterprises on the basis of the following criteria, namely:-

- a) Micro Enterprises: where the investment in plant and machinery or equipment does not exceed one crore rupees and turnover does not exceed five crore rupees;
- Small Enterprises: where the investment in plant and machinery or equipment does not exceed ten crore rupees and turnover does not exceed fifty crore rupees; and
- c) Medium Enterprises: where the investment in plant and machinery or equipment does not exceed fifty crore rupees and turnover does not exceed two hundred and fifty crore rupees.



To facilitate the procedure of MSME registration in accordance with the revised MSME definition.

Ministry of MSME launched a portal-Udyam Registration Portal (https://udyamregistration.gov.in) on 1st July 2020.

Key features of the portal are as under: -

- It is a unified portal with registration process free of cost, paperless and digital.
- The portal is aimed at reducing transaction time and cost for entrepreneurs and promotes Ease of Doing Business.
- The new MSME registration process is simple, seamless and entrepreneur friendly.
- All the relevant data is being fetched from Income Tax and GST Networks at the backend.
- Udyam Registration is mandatory to avail benefits under most of the schemes
 of Ministry of MSME and availing credit from financial institutions as per RBI
 notification no. RBI/2020-2021/26dated 21st August, 2020.

- Ministry of MSME has also commenced API integration of Udyam Registration portal with GeM so that MSEs can participate in Government procurement easily.

M/o MSME has issued a notification on 5th March, 2021 for certain amendments in the earlier notification dated 26th June, 2020. The amendments made are as follows:-

- 1. The exemption from the requirement of having GSTIN shall be as per the provisions of the Central Goods and Services Tax Act, 2017 (12 of 2017).
- In case of any proprietorship Enterprises not registered under any Act or rules of the Central Government or the State Government, the proprietor may use his or her PAN for registration of the Enterprises in the Udyam Registration portal and for all other types of Enterprises PAN shall be mandatory.

Highlights of the Udyam Registration process are as under:

- Aadhaar/PAN is required for registration;
- After completion of the process of registration, an Udyam Registration Certificate will be issued;
- This certificate will have a dynamic QR Code from which the web page on Udyam Registration Portal and details about the Enterprises can be accessed;
- There will be no need for renewal of Registration;
- PAN & GST linked details on investment and turnover of Enterprises will be taken automatically from the respective Government databases;

No Enterprises is supposed to file more than one Udyam Registration.
 However, any number of activities including manufacturing or services, or both, may be specified or added in one Registration.

Government's Facilitation mechanism –68 State Champions Control Rooms, Field Institutions/Offices of Ministry of MSME and DICs:

Upto 31st March 2021, 26,42,250 MSMEs were registered on Udyam Registration portal comprising of 24,48,994 Micro (93%); 1,69,423 Small (6%) and 23,833 Medium (1%) Enterprises.

"This Bulletin contains analysis of 1,73,564 no. of MSMEs registered on Udyam Registration portal as Private/Public Ltd. Companies, upto 31st March,2021.".

2. Distribution of MSMEs (Private/Public Ltd. Companies)

1,73,564 no. of MSMEs were registered on Udyam Registration portal as Private/Public Ltd. Companies, comprising of **1,12,652 Micro (65%)**; **46,443 Small (27%)** and **14,469 Medium (8%)** Private/Public Ltd. Companies.




Figure 1:Distribution of MSMEs (Private/Public Ltd. Companies)

3. Distribution of MSMEs (Private/Public Ltd. Companies) in Top 10 States/U.Ts)

Maharashtra has the highest number of Private/Public Ltd. MSMEs with a share of 20.6%, followed by Tamil Nadu (9.8%), Gujarat (8.6%), Rajasthan (8.4%), and Uttar Pradesh (7.7%).




Figure 2: Distribution of MSMEs (Private/Public Ltd. Companies): Top 10 States/U.T.s

The graph below shows top 10 states/UTs having Udyam registration as **Micro Enterprises** (Private/Public Ltd. Companies). It can be observed that Maharashtra has the highest number of Micro Enterprises with a share of 21%, followed by Delhi (9.8%), Tamil Nadu (8.8%), Uttar Pradesh (8.5%) and Karnataka (7.8%).




Figure 3: Distribution of Micro Enterprises (Private/Public Ltd. Companies): Top 10 States/U.T.s




Figure 4: Distribution of Small Enterprises (Private/Public Ltd. Companies): Top 10 States/U.T.s

The above graph shows top 10 states/UTs for **Small Enterprises** (Private/Public Ltd. Companies). It can be observed that Maharashtra has the highest number of Small Enterprises with a share of 20.3%. The rest of the states are Gujarat (11.4%), Delhi (9.9%), Tamil Nadu (8.3%), and Karnataka (6.6%).




Figure 5: Distribution of Medium Enterprises (Private/Public Ltd. Companies): Top 10 States/U.T.s

4. Distribution of MSMEs (Private/Public Ltd. Companies): Region wise




Figure 6: Distribution of MSMEs (Private/Public Ltd. Companies): Northern Region




Figure 7: Distribution of MSMEs (Private/Public Ltd. Companies): Eastern Region

Southern Region




Figure 8: Distribution of MSMEs (Private/Public Ltd. Companies): Southern Zone

Western Region




Figure 9: Distribution of MSMEs (Private/Public Ltd. Companies): Western Region




Figure 10: Distribution of MSMEs (Private/Public Ltd. Companies): Central Region

North Eastern Region




Figure 11: Distribution of MSMEs (Private/Public Ltd. Companies): NER Region




Figure 12: District wise distribution of MSMEs (Private/Public Ltd. Companies): Top 10 Districts




Figure 13: District wise distribution of Micro Enterprises (Private/Public Ltd. Companies): Top 10 Districts

In the country, the highest registrations of **Micro Enterprises** (Private/Public Ltd. Companies) are from Bengaluru (Urban) having a share of 5.7%, followed by Pune, (4.6%), Mumbai (3.7%), Chennai (3.3%), Thane (2.9%) etc.




Figure 14: District wise distribution of Small Enterprises (Private/Public Ltd. Companies): Top 10 Districts




Figure 15: District wise distribution of Medium Enterprises (Private/Public Ltd. Companies): Top 10 Districts

6. Udyam Registrations in Aspirational Districts(Private/Public Ltd. Companies)




Figure 16: Top 10 Aspirational Districts in terms of Udyam Registrations

7. State wise Employment (Private/Public Ltd. Companies)




Figure 17:Top 10 States/UTs with highest number of Employment and Average Employment per firm: Total (Private/Public Ltd. Companies)

Above graph showcases top 10 States/UTs with highest number of employment and the average employment per Private/Public Companies. It can be seen that even though Maharashtra has highest employment among MSMEs, but the average employment per firm is 40, however in West Bengal and Haryana, the average employment per enterprise is 56 and 55 respectively. The average employment per enterprise in top 10 states/UT is 48.




Figure 18: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Micro Enterprises (Private/Public Ltd. Companies)

Above graph showcases top 10 States/UTs with highest number of employment and the average employment per Micro Enterprise. It can be seen that Maharashtra has highest employment among Micro enterprises, the average employment per firm is 14, however in Bihar, the average employment per enterprise is seen as 30. The average employment per Micro enterprise in top 10 states/UT is 18.




Figure 19: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Small Enterprises (Private/Public Ltd. Companies)

The state wise distribution of employment in Small Enterprises (Pvt. And Public Companies) among the top 10 States/UTs are highlighted above with Maharashtra generating the highest employment and the average employment per Small enterprise is varying from 52 to 92 persons. The average employment per Small enterprise in top 10 states/UT is 70.




Figure 20: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Medium Enterprises (Private/Public Ltd. Companies)

The above graph (figure 20) indicates the state wise distribution of employment in Medium Enterprises (Private/Public Ltd. Companies) among the top 10 States/UTs. It can be observed that Maharashtra, Tamil Nadu and Gujarat have the highest employment in Medium Enterprises. The average employment per Medium enterprise in top 10 states/UT is 219.

8. Gender wise distribution (Private/Public Companies)

The graph below highlights the percentage distribution of Private/Public Ltd. MSMEs on the basis of **Gender ownership**. Male owned Pvt./Public Ltd. Companies constitute 72%, followed by female owned Pvt./Public Ltd. Companies at 21%. The rest share (7%) is constituted by other and unidentified firms.




Figure 21: Gender wise distribution (Private/Public Companies)




Figure 22 Social category wise distribution (Private/Public Companies)




Figure 23: Companies owned by Divyangjan(Private/Public Companies)




Figure 24: Type of Companies by nature of business(Private/Public Companies)




Figure 28: Top 5 NIC code distribution of MSMEs (Pvt./Public Ltd. Companies)




Figure 29 Top 5 NIC distribution of MSMEs (Pvt./public Ltd. Companies):SC ownership




Figure 30: Top 5 NIC distribution of MSMEs (Pvt./public Ltd. Companies): ST ownership




Figure 31: Top 5 NIC (2 digit) distribution of MSMEs (Pvt./Public Ltd. Companies): Women ownership
