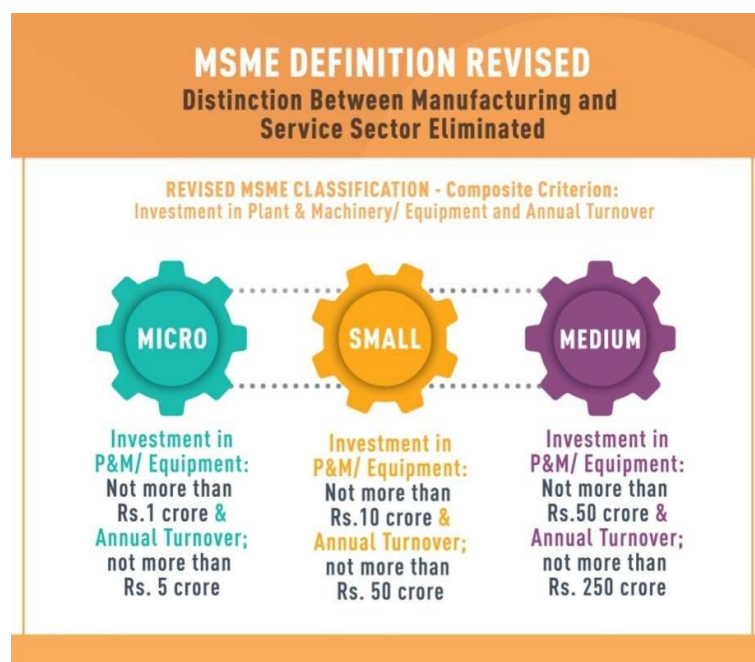

1. Background

The Ministry of Micro, Small and Medium Enterprises issued a notification dated 26th June 2020 regarding revision of definition of Micro, Small and Medium Enterprises (MSMEs) and process of registration. Apart from the old criteria of categorization of MSMEs on the basis of investment in Plant and Machinery/Equipment, an additional criterion of turnover has been included. Moreover, the difference between manufacturing and services sector has been removed and now both are at the same level of treatment. This revision is paving the way for strengthening of Atmanirbhar Bharat Abhiyan and growth of the MSMEs. Particularly, the provision of excluding the exports from counting of turnover is encouraging the MSMEs to export more and more without fearing to forego the benefits of being an MSME.

As a result of change in classification criteria w.e.f. 1st July 2020, an Enterprises is being classified as a Micro, Small or Medium Enterprises on the basis of the following criteria, namely:-

- a) **Micro Enterprises:** where the investment in plant and machinery or equipment does not exceed **one crore rupees** and turnover does not exceed **five crore rupees**;
- b) **Small Enterprises:** where the investment in plant and machinery or equipment does not exceed **ten crore rupees** and turnover does not exceed **fifty crore rupees**; and
- c) **Medium Enterprises:** where the investment in plant and machinery or equipment does not exceed **fifty crore rupees** and turnover does not exceed **two hundred and fifty crore rupees**.



Ministry of MSME launched a portal-Udyam Registration Portal (<https://udyamregistration.gov.in>) on 1st July 2020.

Key features of the portal are as under: -

- It is a unified portal with registration process free of cost, paperless and digital.
- The portal is aimed at reducing transaction time and cost for entrepreneurs and promotes Ease of Doing Business.
- The new MSME registration process is simple, seamless and entrepreneur friendly.
- All the relevant data is being fetched from Income Tax and GST Networks at the backend.
- Udyam Registration is mandatory to avail benefits under most of the schemes of Ministry of MSME and availing credit from financial institutions as per RBI notification no. RBI/2020-2021/26 dated 21st August, 2020. (https://www.rbi.org.in/Scripts/BS_CircularIndexDisplay.aspx?Id=11951)
- M/o MSME has also commenced API integration of Udyam Registration portal with GeM so that MSEs can participate in Government procurement easily.

M/o MSME issued a notification on 5th March, 2021 for certain amendments in the earlier notification dated 26th June, 2020. The amendments made are as follows:-

1. *The exemption from the requirement of having GSTIN shall be as per the provisions of the Central Goods and Services Tax Act, 2017 (12 of 2017).*
2. *In case of any proprietorship Enterprises not registered under any Act or rules of the Central Government or the State Government, the proprietor may use his or her PAN for registration of the Enterprises in the Udyam Registration portal and for all other types of Enterprises PAN shall be mandatory.*

Addition of Activities (NIC code) under MSMED Act, 2006 for Udyam Registration - Retail and Wholesale Trade

Now, Retail and wholesale trades are allowed to be registered on Udyam Registration Portal as MSMEs. However, benefits to Retail and Wholesale trade MSMEs are to be restricted to Priority Sector Lending only.

The list of eligible additional activities is as under:

45	Wholesale and retail trade and repair of motor vehicle and motorcycles
46	Wholesale trade except of motor vehicles and motor cycles
47	Retail Trade Except of Motor Vehicles and motor cycles

Highlights of the Udyam Registration process are as under:

- Aadhaar/PAN is required for registration;
- After completion of the process of registration, an Udyam Registration Certificate will be issued;
- This certificate will have a dynamic QR Code from which the web page on Udyam Registration Portal and details about the Enterprises can be accessed;
- There will be no need for renewal of Registration;
- PAN & GST linked details on investment and turnover of Enterprises will be taken automatically from the respective Government databases;
- No Enterprises is supposed to file more than one Udyam Registration. However, any number of activities including manufacturing or services, or both, may be specified or added in one Registration.

Government's Facilitation mechanism– 68 State Champions Control Rooms, Field Institutions/Offices of Ministry of MSME and DICs;

M/o MSME issued a clarification on 28th September, 2021 regarding Financial Year in respect of the data of Investment, Turnover and Export from the IT Department and GSTN for effecting the Classification of MSMEs.

Upto 30th November, 2021 – Total 58,90,301 MSMEs were registered on Udyam Registration portal.

Out of 58,90,301 MSMEs, 5,608 MSMEs (0.1%) were registered as Cooperatives, comprising 5,289 Micro Enterprises (94.31%), 252 (4.49%) as Small Enterprises and 67 as Medium Enterprises(1.19%).

This Bulletin contains Analysis of Udyam Registration data for the MSMEs registered as Cooperatives till 30th November, 2021.

2. Distribution of MSMEs registered as COOPERATIVES

5,608 number of MSMEs were registered on Udyam Registration portal, till 30.11.2021 comprising of 5,289 Micro (94.31%); 252 Small (4.49%) and 67 Medium Enterprises (1.19%).

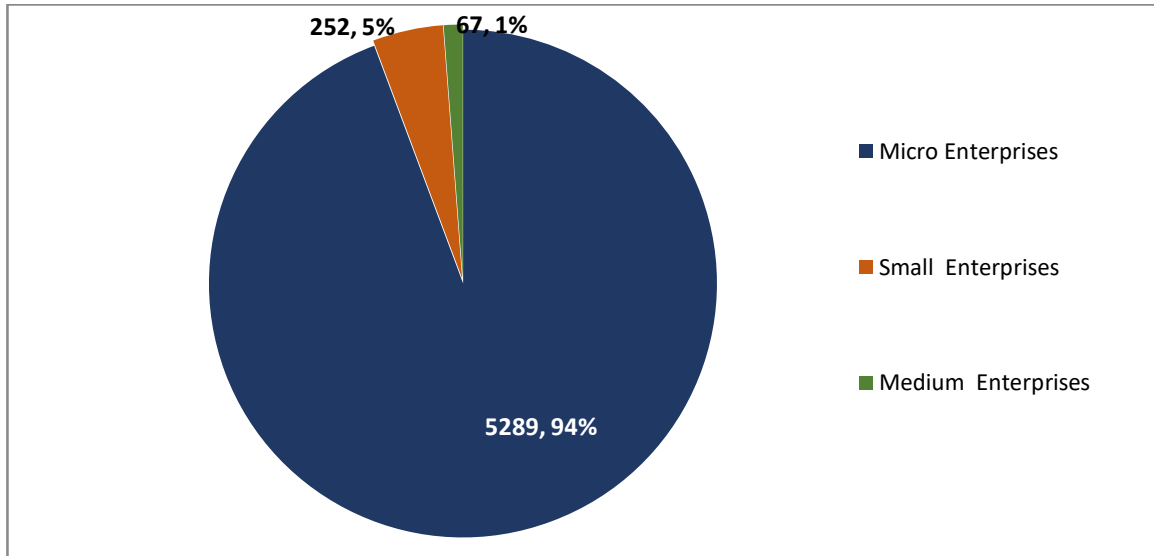


Figure 1: Distribution of Micro, Small and Medium Enterprises

3. Distribution of MSMEs registered as COOPERATIVES (Top 10 States/U.Ts)

Rajasthan has the highest number of MSMEs registered as COOPERATIVES with a share of 15.34%, followed narrowly by Maharashtra (15.25%), Tamil Nadu (12.48%), Bihar (6.37%), and Uttar Pradesh (5.42%).

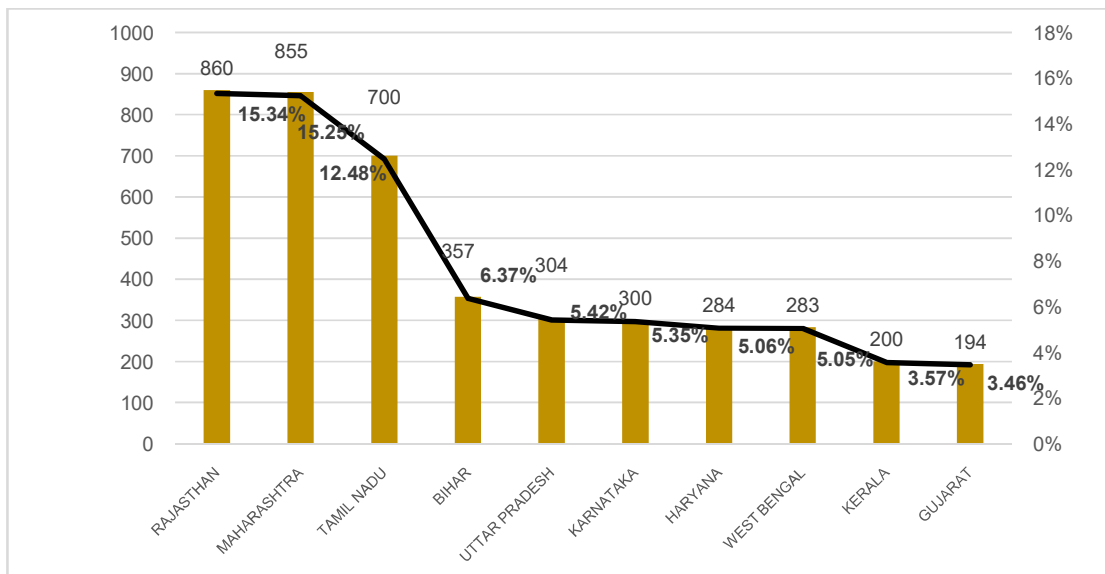


Figure 2: Distribution of MSMEs : Top 10 States/U.T.s

The graph below shows top 10 states/UTs having Udyam registration as **Micro Enterprises under COOPERATIVES**. It can be observed that **Rajasthan has the highest number of Micro Enterprises** with a share of **15.92%**, followed by Maharashtra (14.31%), Tamil Nadu (12.74%), Bihar (6.67%) and Uttar Pradesh (5.52%).

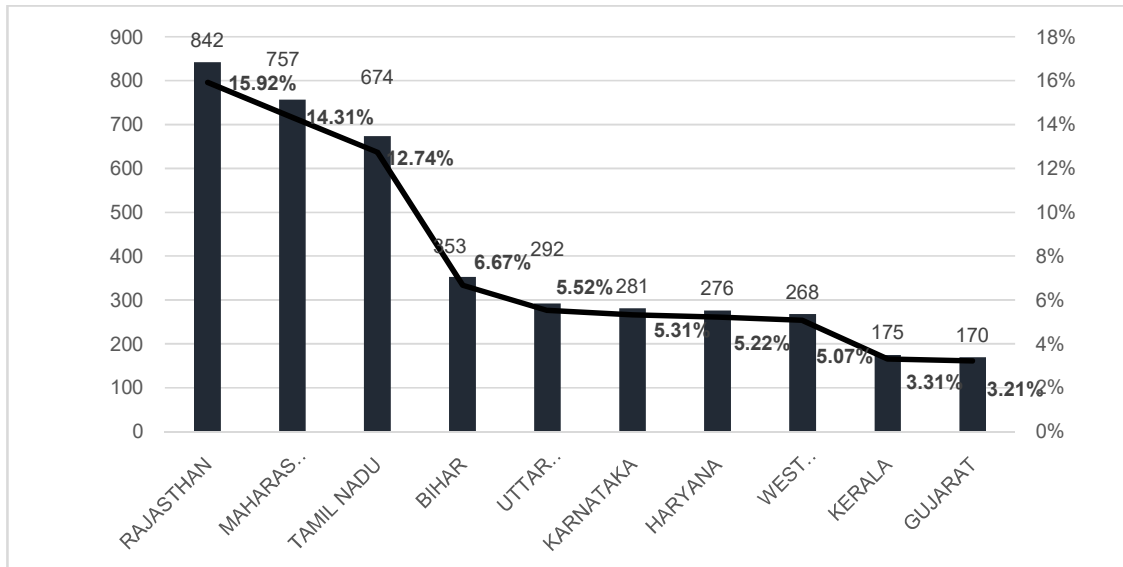


Figure 3: Distribution of Micro Enterprises: Top 10 States/U.T.s

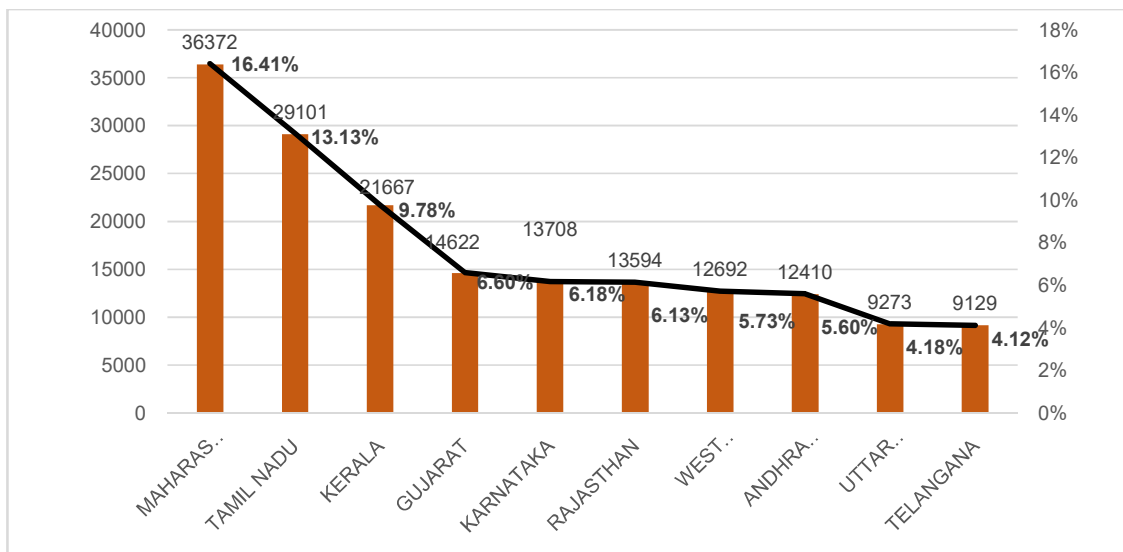


Figure 4: Distribution of Small Enterprises: Top 10 States/U.T.s

The above graph shows top 10 states/UTs for **Small Enterprises registered as COOPERATIVES**. It can be observed that **Maharashtra has the highest number of Small Enterprises** with a share of **16.41%**. The rest of the states are Tamil Nadu (13.13%), Kerala (9.78%), Gujarat (6.6%), Karnataka (6.18%), Rajasthan (6.13%) and West Bengal (5.73%).

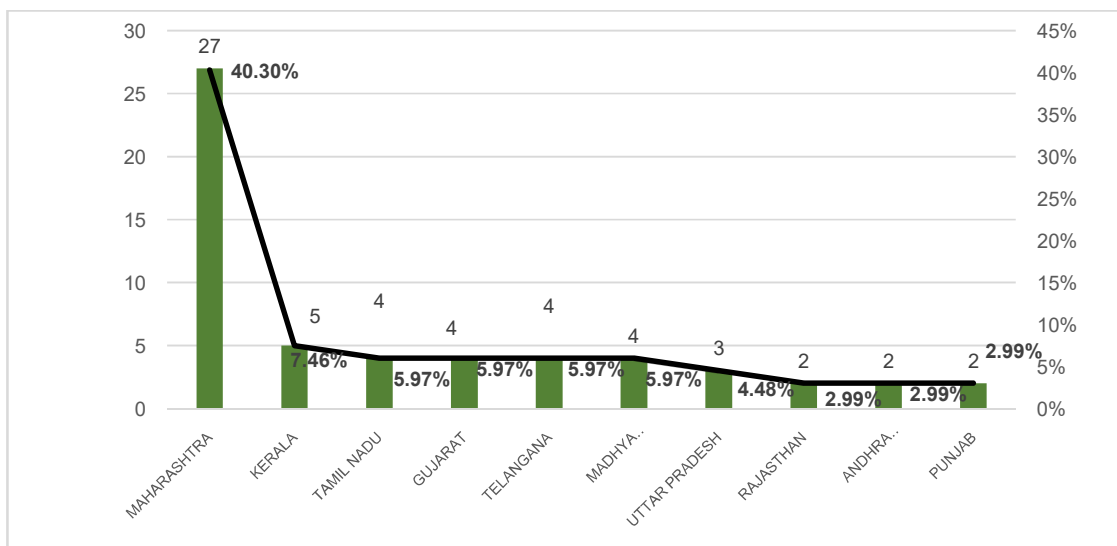


Figure 5: Distribution of Medium Enterprises: Top 10 States/U.T.s

Figure 5 highlights the distribution of **Medium Enterprises registered as COOPERATIVES** in the top 10 States/UTs. These are **Maharashtra with a whopping rate of 40.3%, followed by Kerala (7.46%), Tamil Nadu, Gujarat (7.5%) and Telangana (5.97%).**

4. Distribution of MSMEs as COOPERATIVES: Region wise

Northern Region

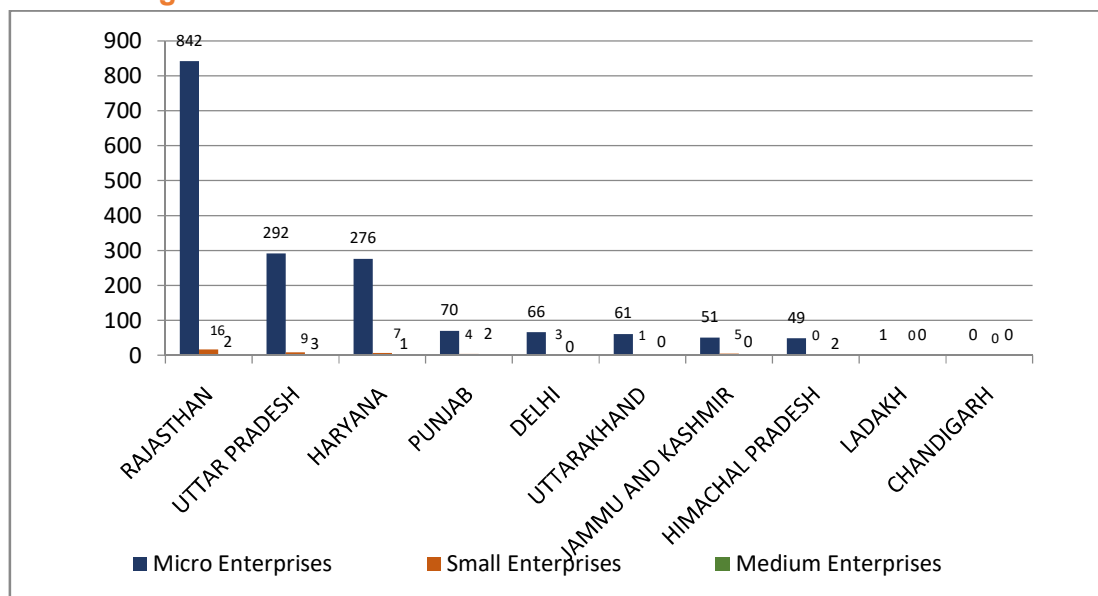


Figure 6: Distribution of MSMEs: Northern Region

Rajasthan, Uttar Pradesh, Haryana, Punjab and Delhi dominate the Northern region. **Northern region contributes 31.43% of the total MSMEs registered as COOPERATIVES.**

Eastern Region

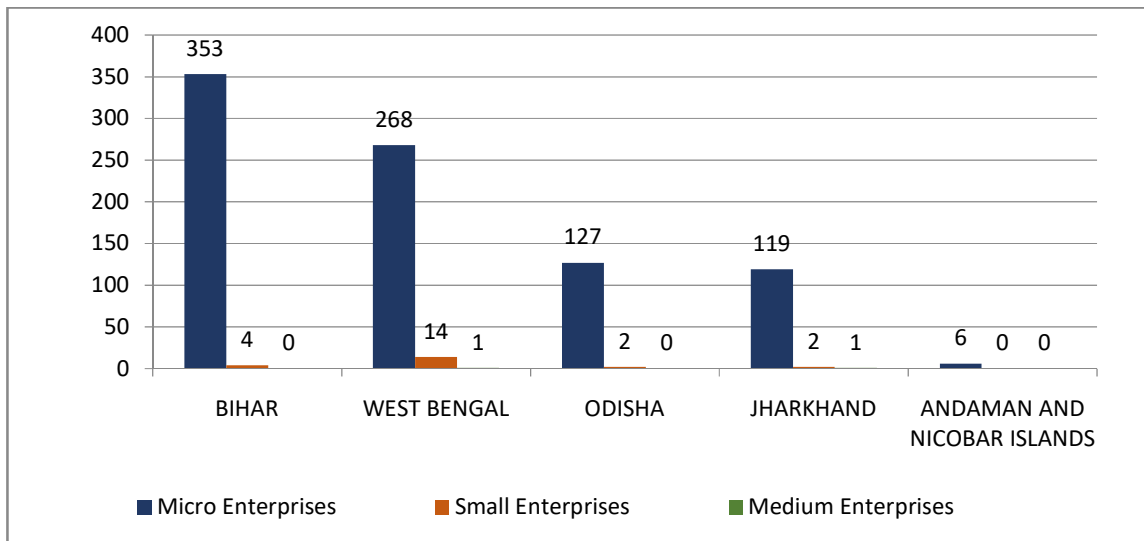


Figure 7: Distribution of MSMEs: Eastern Region

The above graph indicates state wise Udyam Registrations of MSMEs as COOPERATIVES in the **Eastern Region**. **Bihar has highest number of Cooperatives MSMEs in the Eastern region**, while in West Bengal there is highest no. of Medium Enterprises. **Eastern region contributes 15.99% of the total MSMEs registered as COOPERATIVES.**

Southern Region

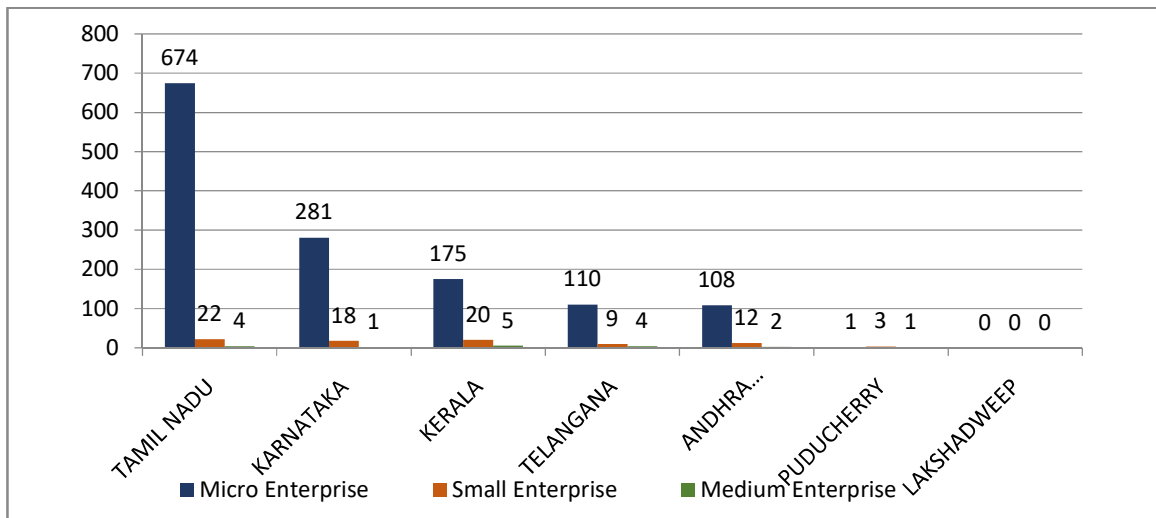


Figure 8: Distribution of MSMEs: Southern Zone

The above graph indicates state wise Udyam Registrations of MSMEs as COOPERATIVES in **Southern Region**. According to the data, **Tamil Nadu dominates the southern region**, followed by Karnataka, Kerala, Telangana and Andhra Pradesh. **Southern region contributes 25.86% of the total MSMEs.**

Western Region

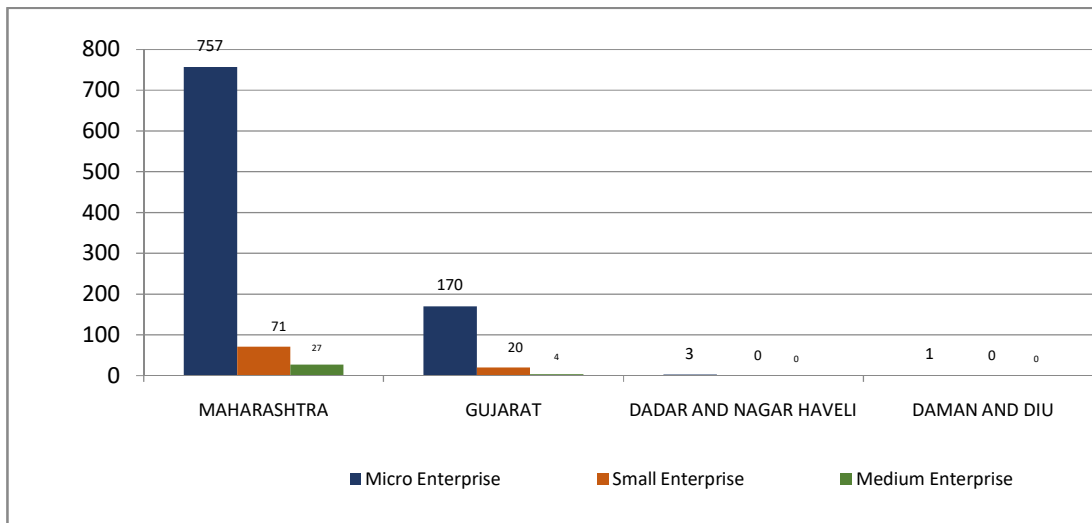


Figure 9: Distribution of MSMEs: Western Region

The above graph indicates state wise Udyam Registrations of MSMEs as COOPERATIVES in **Western Region**. As seen, the majority of MSMEs are located in **Maharashtra and Gujarat**. **Western region contributes 20.77% of the total MSMEs.**

Central Region

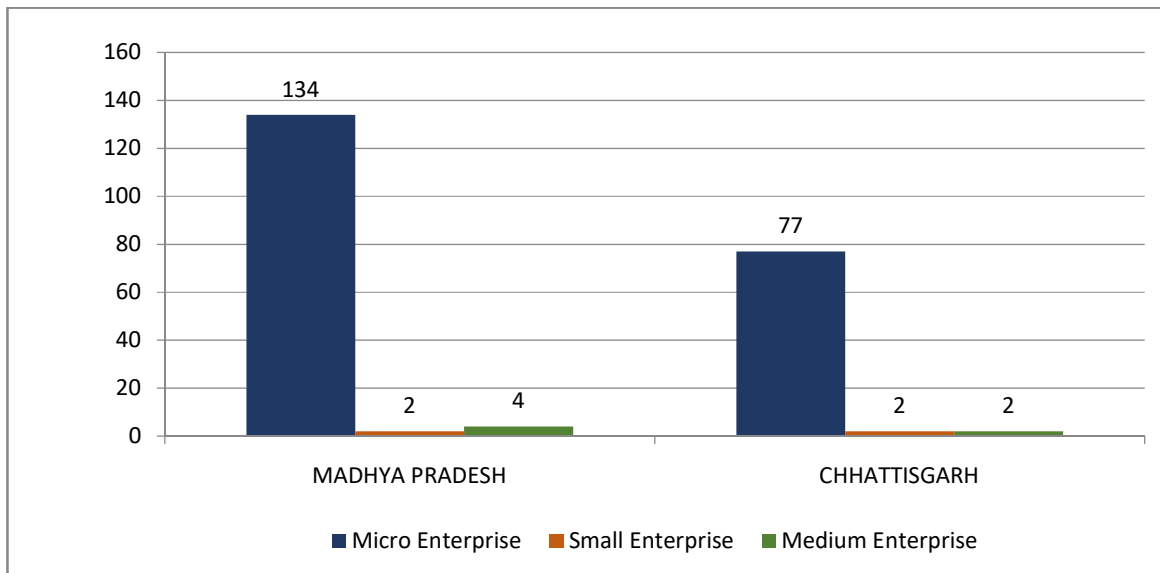


Figure 10: Distribution of MSMEs: Central Region

The above graph indicates state wise Udyam Registrations of MSMEs under COOPERATIVES in the **Central Region**. **Central region contributes 3.94% of the total MSMEs.**

North Eastern Region

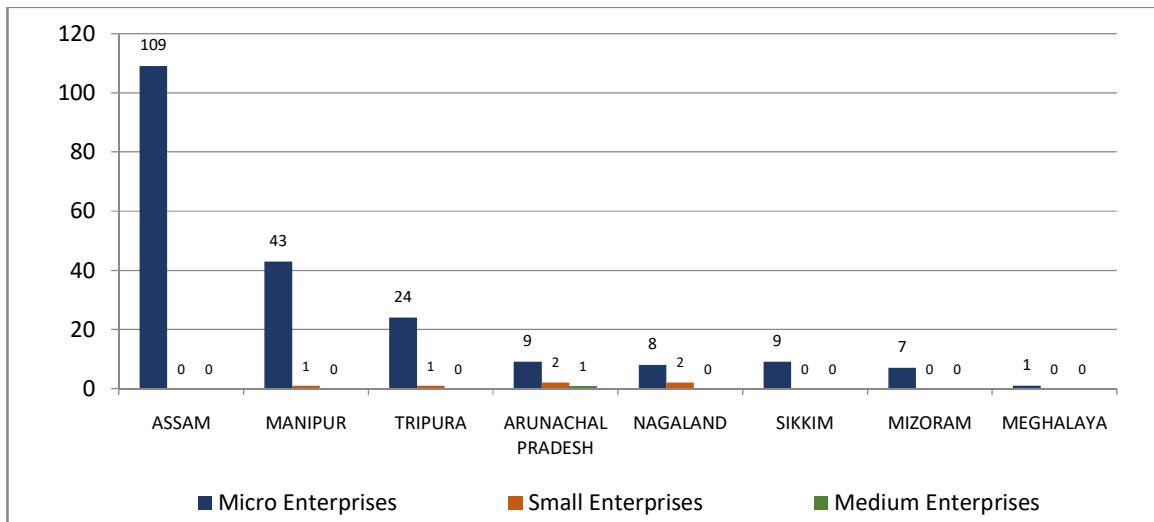


Figure 11: Distribution of MSMEs: NER Region

The above graph indicates state wise Udyam Registrations of MSMEs under COOPERATIVES in **North Eastern Region**. According to data, 84% MSMEs are from Assam and Manipur. **NER region contributes 4.28% of the total COOPERATIVE MSMEs.**

5. Distribution of MSMEs registered as COOPERATIVES - District wise

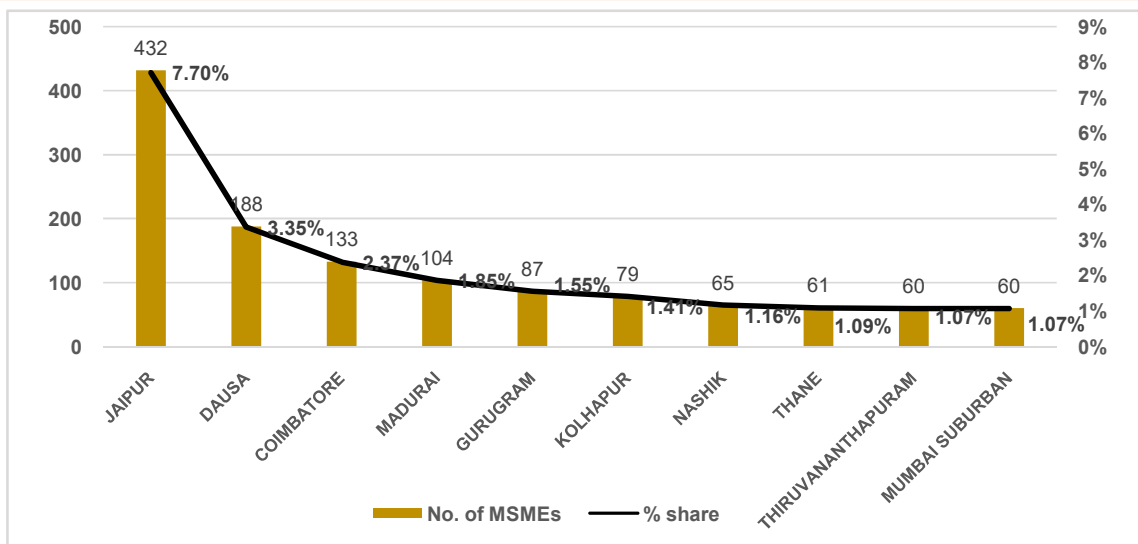
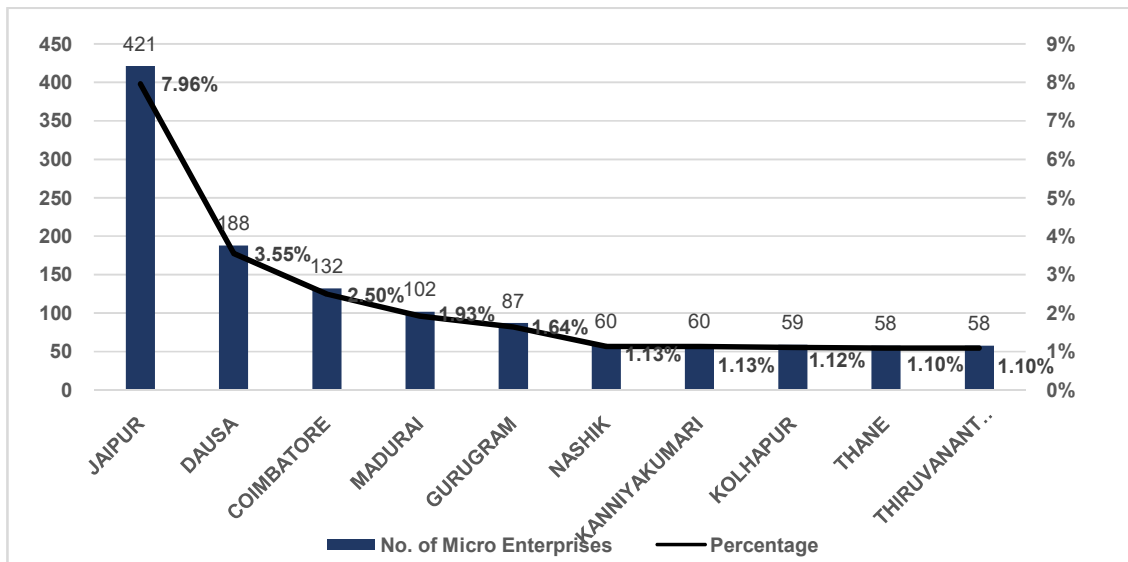


Figure 12: District wise distribution of MSMEs: Top 10 Districts

Figure 12 showcases **top 10 districts** for registration of MSMEs under COOPERATIVES in Udyam Registration portal. It can be seen among the top 10 districts, in **Jaipur** there are highest no. of **COOPERATIVE MSMEs**. In the top 10 districts list, **four districts** are from **Maharashtra**, **two districts** each from **Rajasthan & Tamil Nadu**, one each from **Haryana** and **Kerala**.

In the country, the highest registration of **Micro Enterprises as COOPERATIVE MSMEs** are in **Jaipur (7.96%)**, Dausa (3.55%), Coimbatore (2.5%), Madurai (1.93%) followed by Gurugram (1.64%) etc.

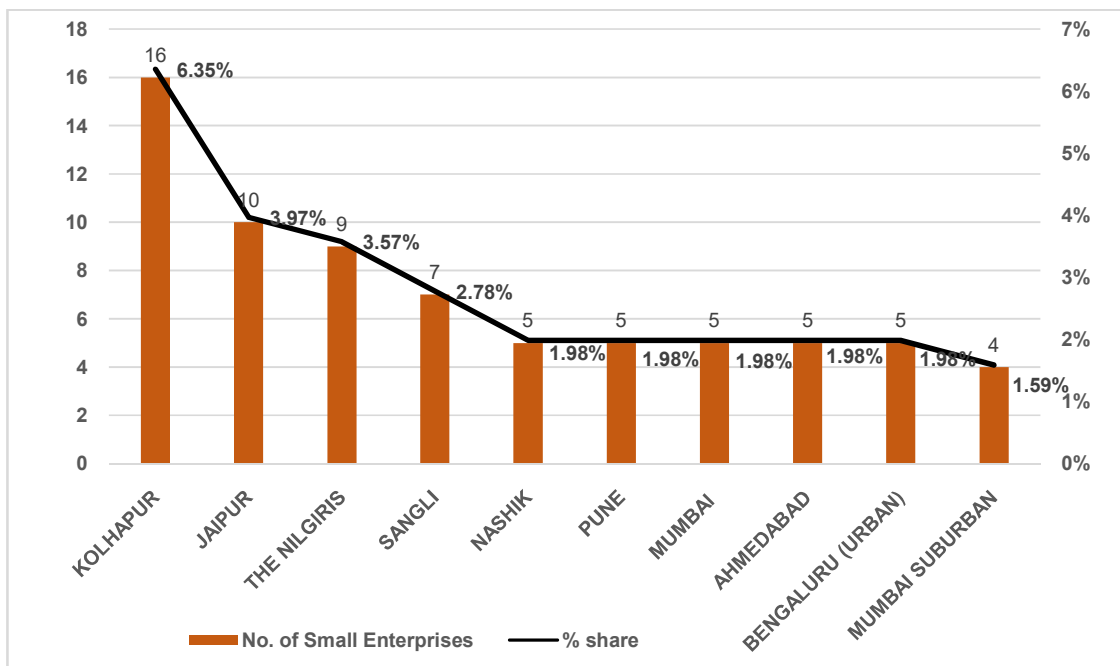


Figure 14: District wise distribution of Small Enterprises: Top 10 Districts

The highest number of **Small Enterprises- COOPERATIVE** registrations are from **Kolhapur (6.35%)** followed by Jaipur (3.97%), The Nilgiris (3.57%), Sangli (2.78%), Nashik, Pune, Mumbai, Ahmedabad, Bengaluru (Urban) (1.98%) each.

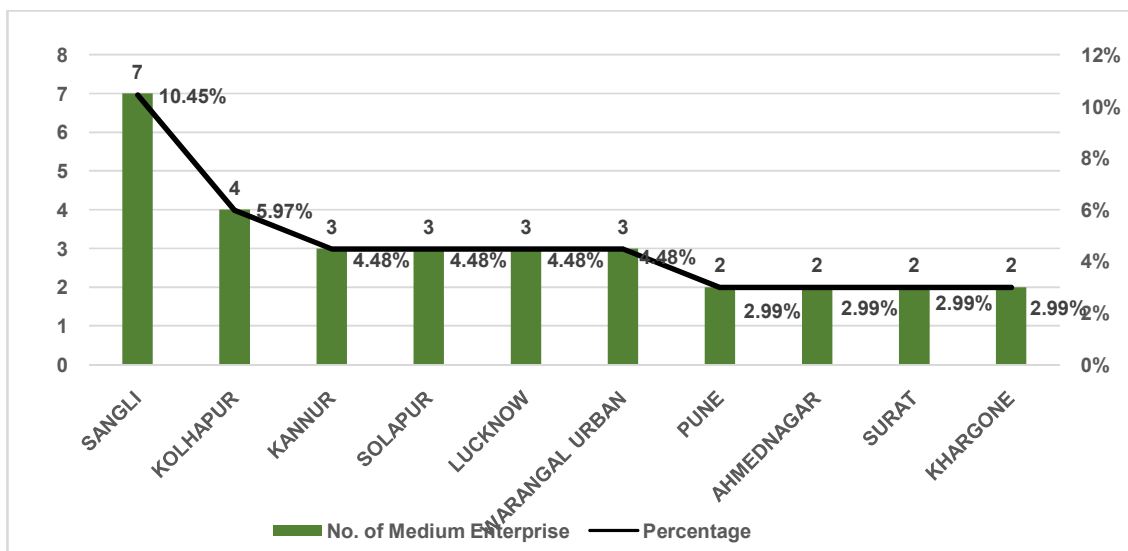


Figure 15: District wise distribution of Medium Enterprises :Top 10 Districts

The top 10 districts having **Medium Enterprise as COOPERATIVES** registrations are indicated in the above graph. It can be observed that the highest number of Medium enterprises are registered in **Sangli district (10.45%)**, followed by Kolhapur (5.97%), Kannur, Solapur and Lucknow (4.48%) each, Pune, Ahmednagar, Surat and Khargone (2.99%) each.

6. Udyam Registrations as COOPERATIVES in Aspirational Districts

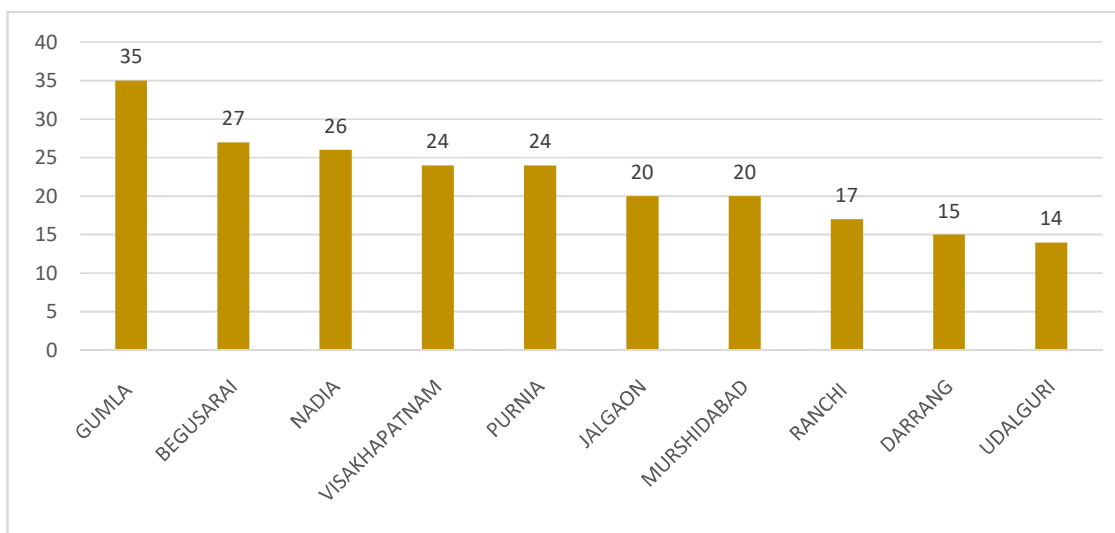


Figure 16: Top 10 Aspirational Districts in terms of Udyam Registrations

The above graph (figure 16) indicates **top 10 Aspirational districts** in terms of Udyam registration of MSMEs under COOPERATIVES. **Gumla district in Jharkhand has the highest number of MSME registration**, followed by Begusarai, Nadia, Visakhapatnam, Purnia, Jalgaon, Murshidabad, Ranchi, Darrang and Udalguri.

7. State wise Employment- MSMEs registered as COOPERATIVES

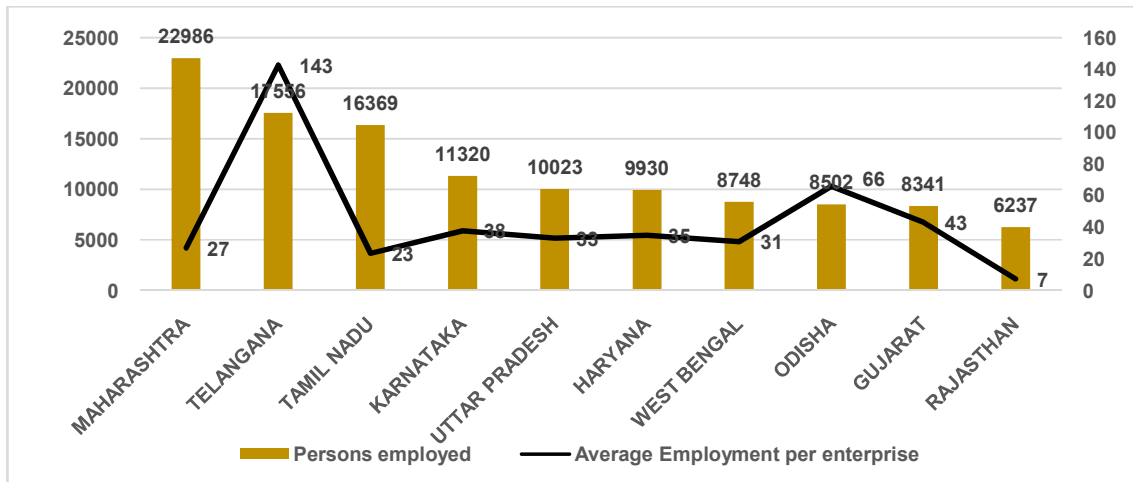


Figure 17: Top 10 States/UTs with highest number of Employment and Average Employment per firm: All MSMEs

Above graph showcases top 10 States/UTs with highest number of employment and the average employment per MSMEs. It can be seen that even though Maharashtra has highest employment, the **average employment per firm is 27**, however in case of Odisha, Gujarat, Karanataka, Haryana, UP and West Bengal the average employment per enterprise ranges between 66-31. Notably, in Telangana the average employment per enterprise is 143. **The average employment per enterprise in top 10 states/UT is 45.**

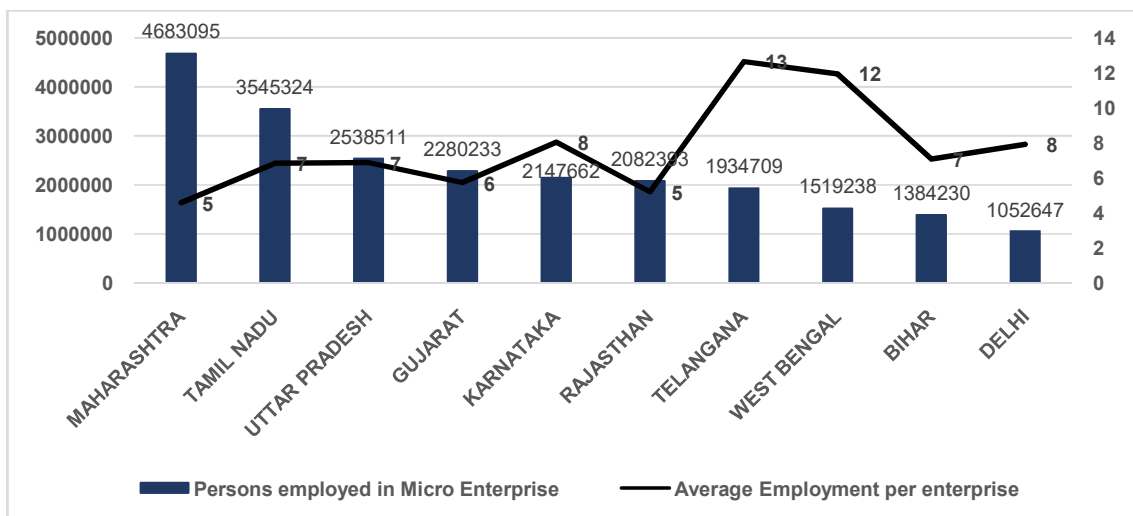


Figure 18: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Micro Enterprises

Above graph showcases top 10 States/UTs with highest number of employment and the average employment per MSMEs. It can be seen that Tamil Nadu generates highest employment in Micro Enterprises, with per unit employment rate at 15 whereas in case of Odisha per unit employment is 66, while it's lowest in case of Rajasthan with rate of 6 per enterprise. **The average employment per enterprise in top 10 states/UT is 30.**

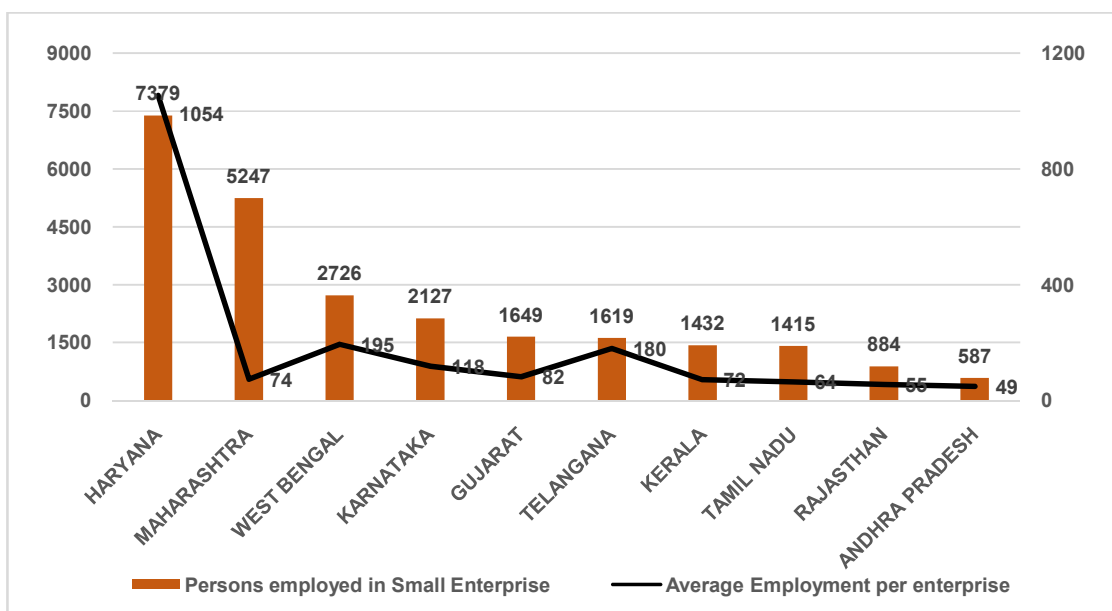


Figure 19: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Small Enterprises

The state wise distribution of employment in Small Enterprises among the top 10 States/UTs are highlighted above with Haryana generating the highest employment with per unit employment rate at 1054 and the average employment per Small enterprise for other states is varying from 49 to 195 persons. **The average employment per Small enterprise in top 10 states/UT is 194.**

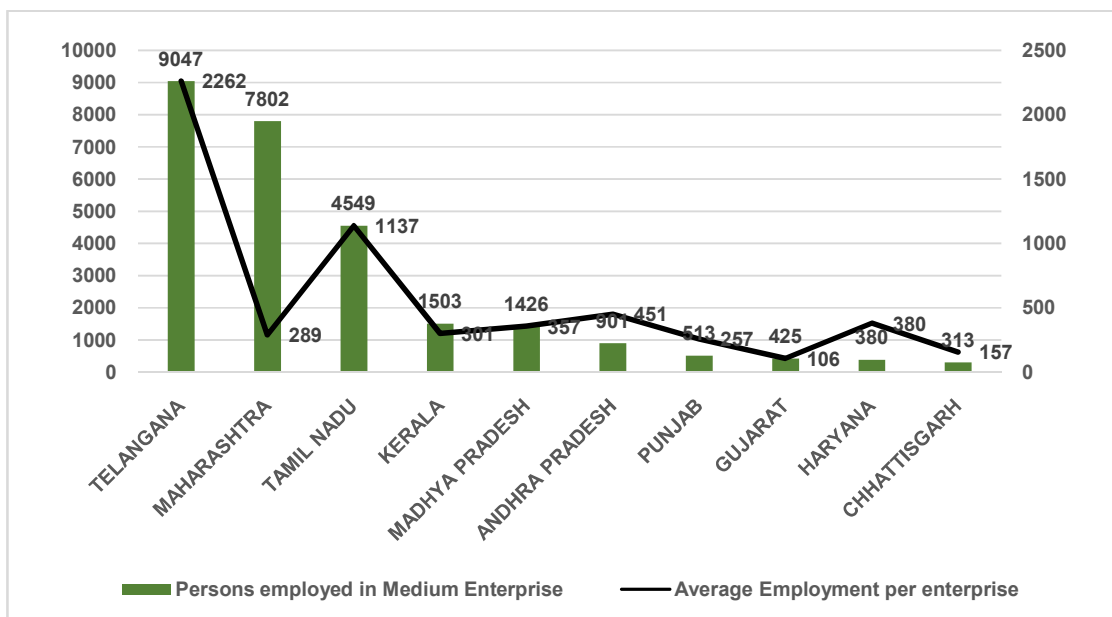


Figure 20: Top 10 States/UTs with highest number of Employment and Average Employment per firm: Medium Enterprises

The above graph (figure 20) indicates the state wise distribution of employment in Medium Enterprises among the top 10 States/UTs. It can be observed that Telangana, Mahasrathtra and Tamil Nadu generate highest employment in Medium Enterprises. **The average employment per Medium enterprise in top 10 states/UT is 569**

8. Gender wise distribution of MSMEs registered as COOPERATIVES

The graph below highlights the percentage distribution of MSMEs on the basis of **Gender ownership**. **Male owned MSMEs constitute 77%**, whereas **17% of MSMEs are owned by female**.

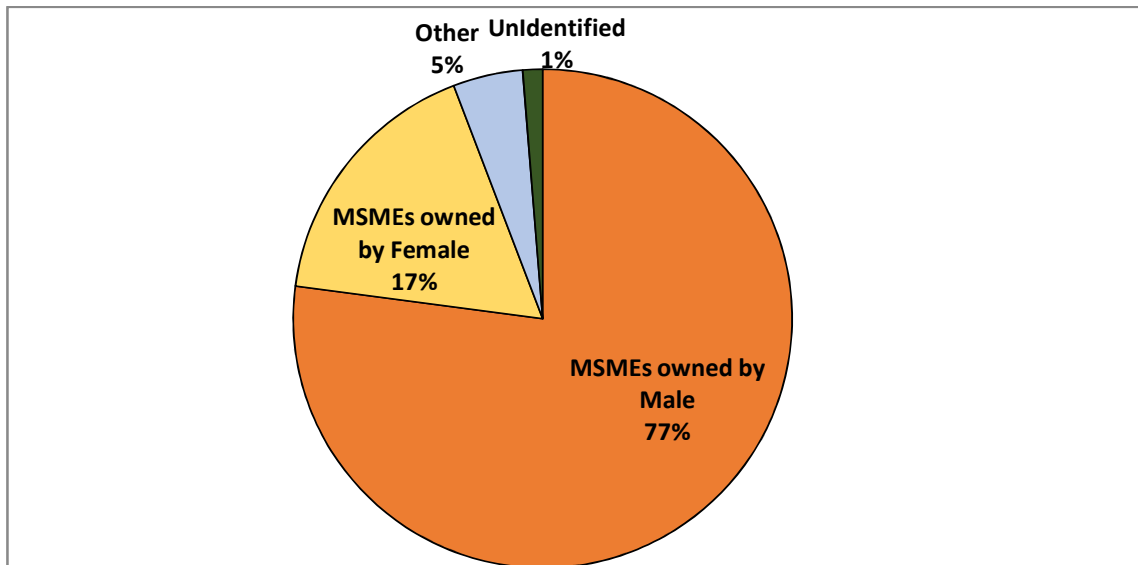


Figure 21: Gender wise distribution of MSMEs

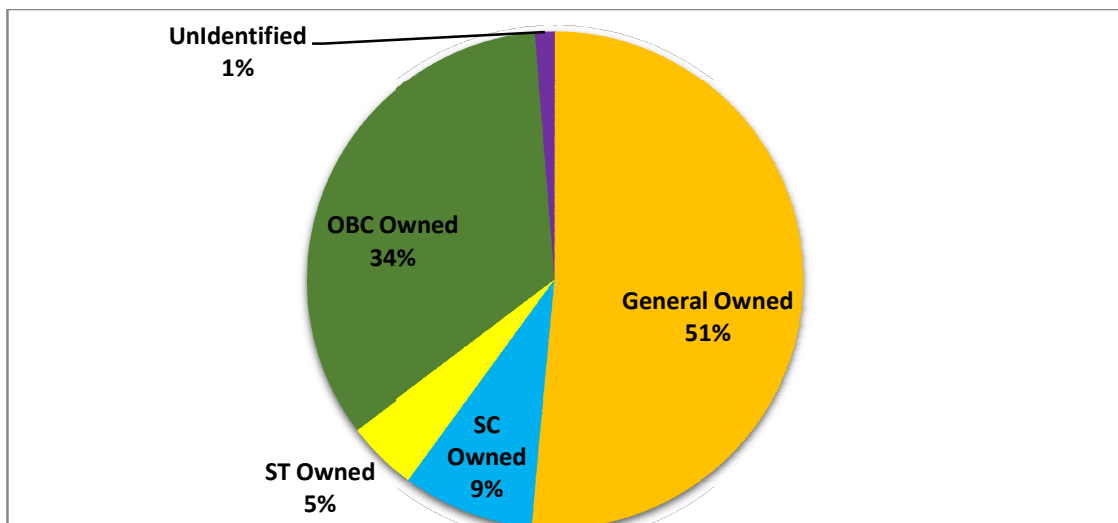


Figure 22 Social category wise distribution

201 COOPERATIVE MSMEs are owned by **Divyangjan entrepreneurs**. The graph below highlights the distribution of MSMEs among them.

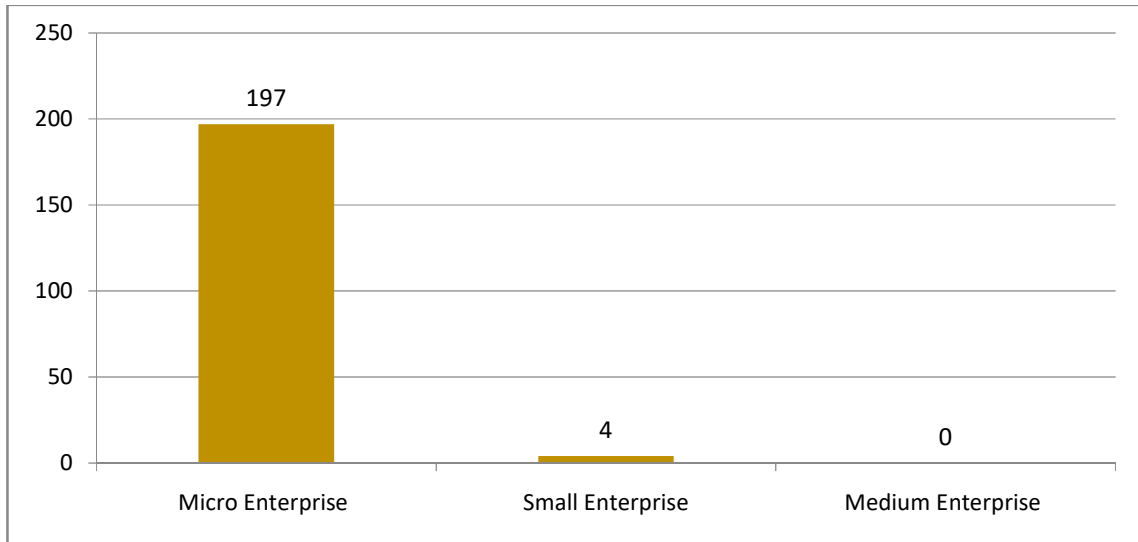


Figure 23: MSMEs owned by Divyangjan

It can be seen that, out of total MSMEs registered on Udyam Registration portal, **41% are from manufacturing sector and 59% of MSMEs belongs Service sector.**

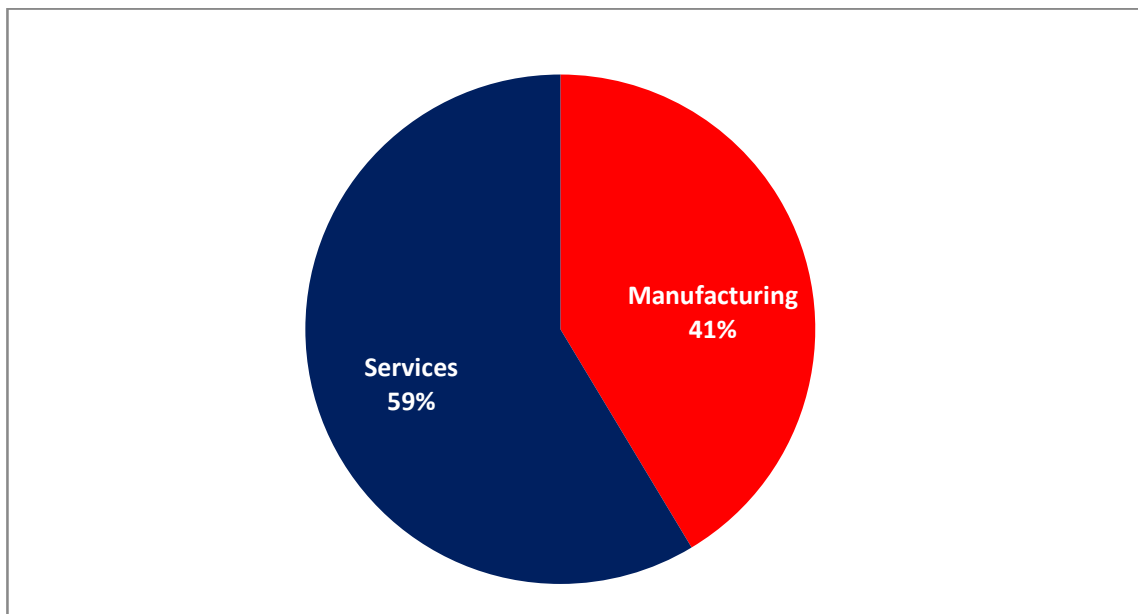


Figure 24: Type of Companies by nature of business

It can be observed that **highest numbers of registered MSMEs under COOPERATIVES** are involved in National Industrial Classification 10- Manufacture of food products, 13-Manufacture of textiles, 56-Food and beverage service activities, 96-Other personal service activities, 01 Crop and animal production, hunting and related service activities, 78-employment activities, 85-Education, 32-Other manufacturing, 42-Civil Engineering, 49-Land transport and transport via pipelines, 56-Food and beverage service activities, 96-Other personal service activities and 32-Other manufacturing.

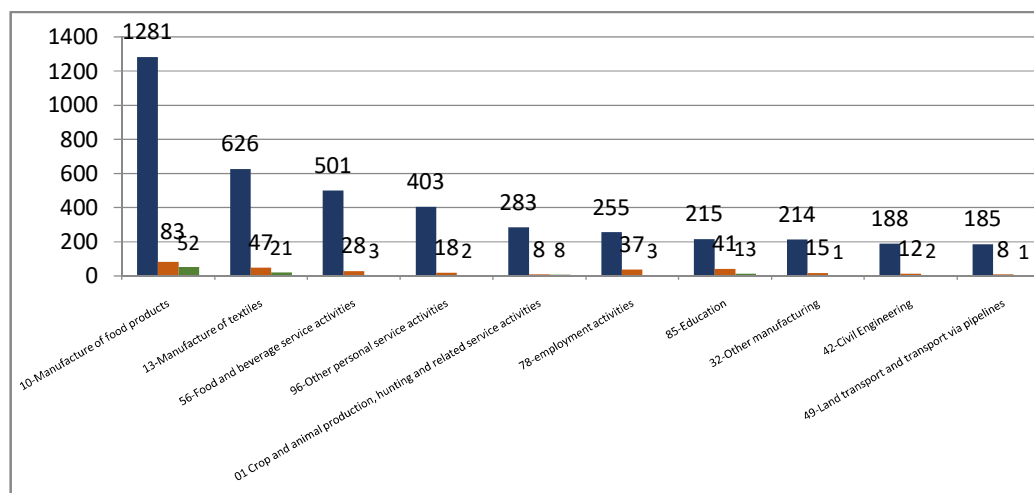


Figure 28: Top 5 NIC code distribution of MSMEs

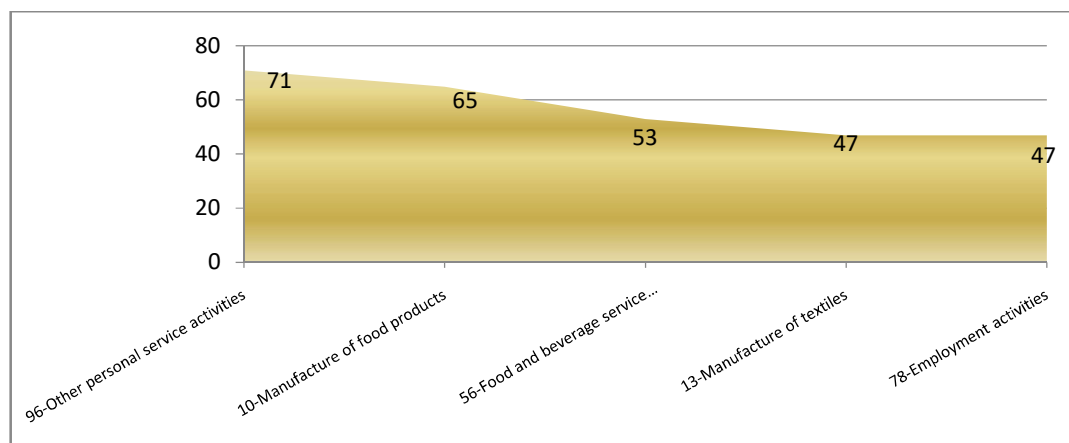


Figure 29 Top 5 NIC distribution of MSMEs: SC ownership

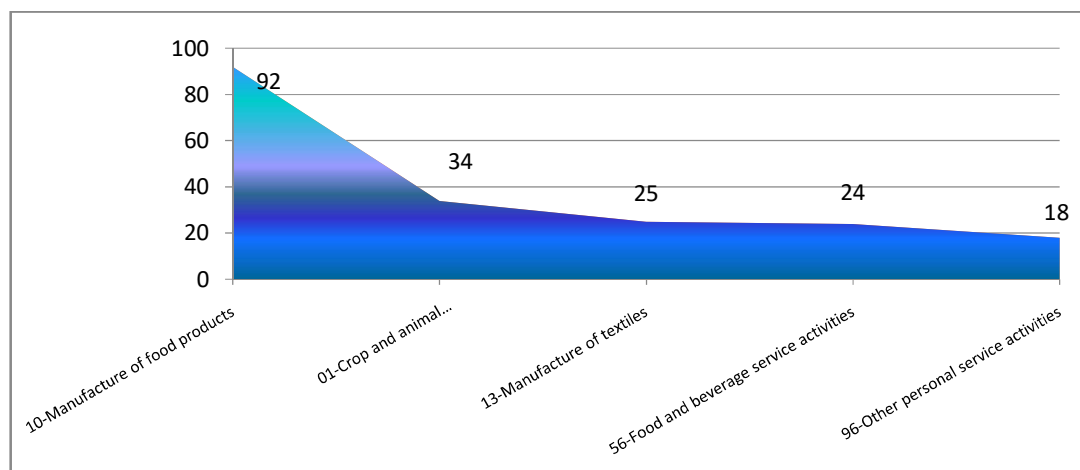


Figure 30: Top 5 NIC distribution of MSMEs: ST ownership

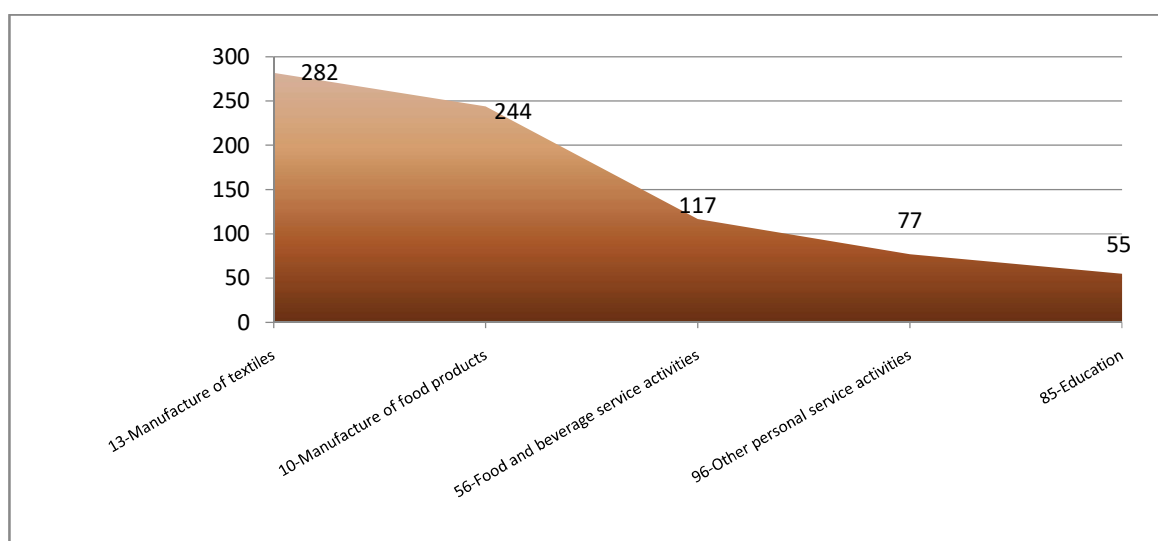


Figure 31: Top 5 NIC (2 digit) distribution of MSMEs: Women ownership
